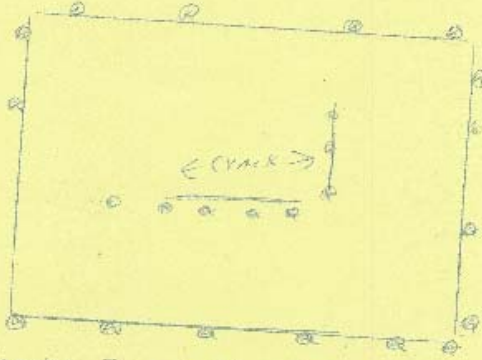

Extreme care will be taken to ensure that the highest quality of work is performed, although for reasons beyond our control, House Doctors CANNOT GUARANTEE THAT CRACKS OR REPAIRATIONS WILL CLOSE, or that shrubs, flowers, grass, etc. removed for piling will not die. The owner further acknowledges that separations in plumbing may have already occurred or may occur while regaining lost elevation and that House Doctors is not responsible unless damage is the result of gross negligence or a willful act. The owner's sole and exclusive remedy shall be for correction of any defect in workmanship, or material as set forth above and in the warranty certificate, and excludes any or all consequential damages. The owner acknowledges that the total extent of House Doctors liability shall not exceed the accepted contract total. This contract may be withdrawn after 30 days.

ROCK/CONCRETE CLAUSE

If an excessive amount of rock or concrete is encountered which interferes with the normal excavation & installation process, an additional charge may be necessary. Any additional charges will be submitted for the customer's approval.
